1.2 The raffle **starts on April 1, 2025, at 08:00 AM CET and ends on June 30, 2025, at 12:00 PM CET** ("Raffle Period"). Participants can enter during the specified period. The organizer reserves the right to extend or shorten the duration of the raffle period without giving reasons.

1.3 IBC SOLAR is giving away 10 spots for a five-day trip to China with Huawei FusionSolar®. The trip is expected to take place in October 2025 and includes flight, accommodation, and selected activities.

### **2. Participation Conditions and Winner Determination**

2.1 Participation in the IBC SOLAR raffle is voluntary and free of charge. Participation is exclusively subject to these terms and conditions. IBC SOLAR reserves the right to exclude participants from the raffle in case of violation of these terms and conditions.

2.2 Participation in the raffle requires an order of Huawei products in the IBC SOLAR online shop and the entry of the code "Huawei China" in the "Commission" field in the shopping cart's order details.

2.3 Each customer has a chance to win a maximum of one of the 10 spots for the trip to China, regardless of the number of orders.

2.4 Eligible participants are all legal entities and natural persons who are at least 18 years old. Employees of IBC SOLAR and its subsidiaries, as well as their relatives, are excluded from participating in the raffle.

### **3. Winner Determination**

The winners will be determined after the end of the raffle period by a random draw among all participants. Legal recourse is excluded. The winners will be personally notified by phone or email. If a winner does not accept the prize, IBC SOLAR will draw another participant. The prize is not transferable to third parties.

#### **4. Data Protection**

4.1 Information about IBC SOLAR as the data controller, as well as detailed information about the processing of personal data, recipients, and participants' rights, can be found [here](#). Additionally, IBC SOLAR informs about the processing of personal data within the framework of the raffle in accordance with Regulation (EU) 2016/679, the General Data Protection Regulation (hereinafter „**GDPR**“).

4.2 The purpose of data processing is to conduct the raffle. The legal basis for processing within the framework of the raffle is Art. 6 para. 1 lit. b GDPR (performance of the raffle contract).

4.3 Within the framework of this raffle, IBC SOLAR processes the first name, last name, address, and email address of the participants; from the winners, the additionally provided data, in particular first and last name and email address, are processed. The collection of this personal data is required for voluntary participation in the raffle. Automated decision-making, including profiling according to Art. 22 para. 1 and 4 GDPR, does not take place. Each participant can contact the data protection officer at [info\[at\]bsp-security.de](mailto:info[at]bsp-security.de) with questions about the collection, processing, and use of their personal data.

4.4 Personal data will be stored as long as the processing purpose exists. The purpose ceases with the conclusion of the raffle by determining the winners and distributing the prizes. After the purpose is fulfilled, the data collected within the framework of the raffle will be deleted, unless legal retention periods require longer storage.
